Reeping Your Benefit Fund Enrollment Status Up to Date is Your Legal Obligation

Too often we do not realize how events in our personal lives affect so many other aspects of our life. One such example is the United Staff Association Welfare Fund and its coverage of you and your eligible dependents.

As you know, the United Staff Association Welfare Fund and its Board of Trustees, are charged, generally, with the proper administration of the plan of benefits, consistent with its Trust document and the law, and limited, specifically, as to whom benefits may be given.

As a beneficiary of the Fund, you also have certain 36th Annualresponsibilities, including the legal responsibility to keep the Fund informed of changes in your status, or in your family members'

For example, if you are divorced, fail to notify the Fund that your ex-spouse is no longer eligible as your dependent, and your ex-spouse receives benefits from the Fund, you may be held financially your ex-spouse.

they are no longer a dependent as defined by the and SRPs to provide effective strategies Fund (e.g., 19 and not attending college), the Fund communication for behavior management. can deny your dependent the right to continue coverage with the Fund, even though you are willing

to pay for it. Once you miss this deadline, your dependent child will <u>never</u> be offered opportunity to continue coverage again.

So, on behalf of the Board of Trustees of United Staff Association Welfare Fund, we urge you to keep your enrollment with the Fund up to date. preserve your rights and save you a lot of money!

Any changes in status in family status, e.g. death, divorce, marriage or birth of a child, should be communicated immediately to the United Staff Association Welfare Fund through its Third-Party Administrator, Daniel H. Cook Associates, Inc. at the following address:

New York State Teachers' Retirement System 2008 Annual Delegates Meeting Saratoga Springs, NY

The annual meeting of the NYTRS was held on Sunday, November 9 and Monday, November 10 at the Saratoga Springs City Center in Saratoga Springs, New York. As your delegate, I attended this conference to vote on behalf of our membership for a Teacher Representative to the executive board. The board oversees the adherence to retirement system rules and regulations, as well as overseeing of the integrity of the system. There was 634 delegates from across our state present at the conference and Paul Fafalia was elected as the teacher representative to the board. Paul has had a long service history and has been attending board meetings prior to his election. Paul should be a valuable addition to the board. His work and contribution to the retirement system is needed more than ever with the economic crisis we are experiencing today.

It was good to hear that through the hard work and effort of our board and trustees over the past 5 years, the retirement fund has been able to achieve a 9.9% return on investments. However with the current economic down turn, the next few years remain unpredictable.

The NYSTRS has vast amounts of resources and information that is available to all members. One of the important things identified at the conference was that all members carefully read their annual benefit

statement which should be arriving in early December. Checking the information listed for accuracy is one of the most important things a member can do. Additionally, making sure that you keep your beneficiary designation up to date is also very important. Life is very busy and gaining or losing a spouse without updating your information could result in a benefit going to someone who you would not choose.

I would recommend that if you have any questions about your NYSTRS benefits, contact a system representative at 1-800-348-7298, ext. 6250 or visit them on the web at www.nystrs.org to access forms and current information. The message from the experts was that each individual has special circumstances and although colleagues may try and be helpful with advice, they may not be aware of an individual's special needs. So again, go to the experts at the NYSTRS; they will be able to give you the best information.


