The New York State United Teachers Association Tarrytown Regional Office sponsored the Summer Leadership Conference August 12- 14 2009 at the Wyndham Forrestal Hotel and Conference Center. As in the past there were many professional workshops available such as : Advanced Leadership Program, Basic Grievance, Basic Negotiations, Basic Union Representative and 16 other informational presentations.

I attended the Advocacy and Taylor Law workshop that proved to be excellent on all counts. The presenter Eric Marshall provided a wealth of information on the Taylor Law, which is a New York State Collective bargaining statute that covers all public employees in New York State.

The Taylor Law:

- Grants public employees the right to organize and be represented by employee organizations (unions) of their choosing
- Requires public employers to negotiate and enter into agreements with public employee organizations regarding their employees terms and conditions of employment
- Establishes procedures for dealing with impasse, and in resolving collective bargaining disputes
- Defines and prohibits Improper Practices
- Prohibits strikes by public employees

Establishes PERB- The Public Employment Relations Board – to administer the law.

The specific content of the statue is extensive but it was very interesting to get insight from Eric who has filed cases and been through the PERB process. The timelines for filing a claim are very specific and can make the difference between successfully scheduling a hearing or being ineligible. The workshop was very understandable and the questions that were discussed dealt with actual Taylor Law issues that have occurred in other districts. Overall, the time I spent in this workshop was well spent.

The accommodations were top shelf. There was unlimited access to refreshments and food. As I have said in the past if members can allocate the time, which I know is always in high demand; then a very enjoyable experience waits. Remember, NYSUT and our local, pay all expenses, including mileage and tolls. As we move forward in time, new active members are necessary to carry on the work that often goes unnoticed by the membership. If you are a person who has the ability to become more active and involved, then only good can come from this. As the older members retire and move on, new members must look to carry on, and continue to promote a strong learning environment for our students and a safe and fair work environment for our membership. We hope that the challenges ahead will be addressed by strong leadership and strong support from our members. In solidarity.

NYSUT BOCES Leadership Conference

I had the privilege of attending the annual NYSUT BOCES Leadership Conference in Albany this fall. As usual, the conference provided a wide variety of particularly relevant workshops. I chose to participate in the workshop on contracts and negotiation and was well rewarded. The workshop provided a detailed overview of the direction that negotiations and contracts are headed in both our region and other areas of NYS, and included a thorough review of the issues we may face as we enter negotiations when our current contract expires.

One of the most interesting things that I learned was that in the upstate area, the increase received when you move to the next step in the salary scale is included when salary increase percentages are negotiated. So for example, if a local negotiates a 3% raise, the increase is not the step plus 3%. The step is included, so a 3% increase may only be a 1% increase plus whatever the step increase is. This accounts for the lower salaries in those areas.

The workshop also dealt extensively with the various ways in which health insurance costs are being negotiated. Some locals have a graduated system, where everyone pays based on their salary, rather than each employee paying the same percentage. So for example, if you are on step 1 you may pay 5% of your health insurance premium, but if you are on Step 10 you might pay 15%.

Another issue of note was how different contracts are structured in terms of the health insurance payments for retirees. The presenter thought our contract had excellent language in this regard, and shared it with the other locals that were represented. We have our

retirees pay a flat amount that does not change, which everyone agreed was a good way to go because retirees are on a fixed income.

The workshop was well worth attending for both the perspective it provided on the major issues in recent negotiations, and the varied ways in which different locals have addressed those issues.
