When we returned after an unsuccessful souvenir hunt - the border guards told us that everything would be closed by the time they let us go (ha ha), it was a four hour marathon of sitting on the Ukraine side, being looked at by border guards, supervisors, etc. They'd look at my passport, then at me, look at

the passport and at me again and repeat it. Six times that I remember. Lots of consultation with one another and a few phone calls. A busload of tourists had to go into the building with their suitcases, open everything and finally reboard, so it wasn't just us, although we did seem to command more attention than anyone else. The border folks had difficulty understanding why I had a Hungarian-registered car (it was leased from the airport there), had a US passport (and a European-looking daughter), was living in Presov and wanted to visit Ukraine. Actually, there was a reasonable explanation for everything, except why I wanted to visit Ukraine. Of course, they finally stamped our passports and let us go, and we now have a good story to tell. We won't be going back anytime soon, tho'. It was a good lesson in democracy....

We'll be heading home in three weeks. I have finished teaching my classes, and we'll be traveling/

A Sad Rite of Spring: Layoffs

For Civil Service Employees:

In the January issue of *The Edge* we focused on the process of abolition of positions, layoffs and recall rights for teachers and teaching assistants. In this edition of *The Edge*, we will feature a comparable article for **Civil Service employees**.

Sadly, spring brings the abolition of positions and layoffs of teachers and school related professionals in many of our school districts. Before *The Edge* provides some reminders about the laws and regulations governing layoffs for civil service employees, let us make one point clear:

The best way to prevent or reduce layoffs is to work to pass your school district's budget on May 19. Let's put our efforts to pass the budget in high gear!

School boards have the right to abolish civil service positions for reasons of economy, consolidation, abolition of functions, or curtailment of activities.

Generally, Civil Service employees' positions are abolished in inverse order of **original permanent appointment** in the classified Civil Service in positions the employer has chosen to eliminate. In our region, typically this Civil Service rule applies solely to competitive class employees; however, local leaders must check the contract language, practice and local Civil Service rules to see if the same rights apply. Employees who are blind, veterans, or spouses of disabled veterans are given preference in layoff situations. In some Civil Service jurisdictions Civil Service employees may receive seniority credit for other positions held in the school district prior to the position being abolished.

In a layoff situation, **competitive class** employees may have an opportunity to bump other less senior employees in the same direct line of promotion, or retreat back to a position in which the employee last served on a permanent basis.

After a layoff has occurred, it is the superintendent's responsibility to provide the name, title or position, date of appointment, and the date of, and reason for, the layoff to the local Civil Service agency. Excessed **competitive class** Civil Service employees are placed on a preferred list and given preference over others in rein-

statement to positions within the **competitive class**. Such employees remain on the preferred list for four (4) years. If a laid-off employee refuses a similar position in the same layoff unit, that employee's name is removed from the preferred list. Other jurisdictional classes of Civil Service employees (i.e. Noncompetitive, Labor, and Exempt classes) do **not** enjoy these rights of seniority, layoff and recall under the civil service law. However, these rights may be provided in some form in the local union contract or by practice in the district. Generally, these are the Civil Service rules regarding seniority, layoffs and recall. However, there may be exceptions for positions in other *jurisdictional classes* (i.e. Noncompetitive, Labor, and Exempt classes) in some Civil Service regional jurisdictions. In addition, seniority, layoff and recall rights for all civil service workers may be expanded in the local union's contract. It is best to ask your NYSUT LRS if you have questions about a member's rights under Civil Service law or your contract.

School boards must act in good faith when such positions are abolished. School boards may not use the abolition of Civil Service positions in matters of employee discipline; that is, positions may not be abolished in an effort to circumvent due process rights provided by Civil Service Law. The burden of proving that a position was abolished in bad faith rests with the employee, who must show that the employer had no bona fide reason for eliminating the position, achieved no cost savings, hired someone else as a replacement, or that the abolition was otherwise motivated by bad faith.

Recommendations from *The Edge*:

- Check your contract; it may afford additional rights regarding layoffs.
- Order copies of NYSUT's Handbook for Laid-Off School Employees from the Tarrytown Regional Office for members who have the misfortune of being excessed.
- When in doubt about layoff issues, check with your NYSUT LRS.

The rules for the abolition of Civil Service positions, layoffs, and recall rights are especially complex and confusing. Do not hesitate to contact your NYSUT LRS regarding these matters in your local.
